

***EVENT PARTICIPATION HOLD-HARMLESS, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT**

Event: Lunar Run Event **Promoter:** Black Hills Chairlift Co. d.b.a. Terry Peak Ski Area **Date:** January 16, 2022

**PLEASE READ CAREFULLY.
THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS**

“PARTICIPANT” MEANS THE UNDERSIGNED ADULT, BEING AT LEAST 18 YEARS OLD, SIGNING ON BEHALF OF HIMSELF/HERSELF OR THE MINOR PARTICIPANT (UNDER 18) AND THE UNDERSIGNED PARENT OR LEGAL GUARDIAN OF THE MINOR SIGNING ON BEHALF OF HIMSELF/HERSELF. PARTICIPANT AGREES AND UNDERSTANDS THAT ASSISTING WITH PREPARATION OF THE LUNAR RUN EVENT AND/OR ANY OTHER USES OF THE SKI AREA FACILITIES CAN BE **HAZARDOUS** AND MAY INVOLVE THE RISK OF PHYSICAL INJURY OR DEATH.

FLAMING THORCHS WILL BE USED IN THE LUNAR RUN, AND BY SIGNING THIS LIABILITY RELEASE FORM, I ACCEPT THE RISKS AND DANGERS THAT ARE AFFILIATED WITH USING FLAMING TORCHES. THE USE OF A FLAMING THORCH IS NOT REQUIRED, AND IF I CHOOSE TO USE A FLAMING THORCH PROVIDED BY THE SKI AREA I DO SO AT MY OWN RISK. I UNDERSTAND THAT BLACK HILLS CHAIRLIFT CO. d.b.a. TERRY PEAK WILL NOT BE RESPONSIBLE FOR DAMAGED CLOTHING. BY SIGNING THIS RELAEASE FORM I’M EXCEPTING RESONSIBILITY OF PARTICIPATING IN THE LUNAR RUN EVENT. I PROCLAIM TO BE AN INTERMEDIATE TO ADVANCED LEVEL SKIER/SNOWBOARDER. THERE IS LIMITED VISIBILITY DUE TO NATURAL LIGHTING AND I UNDERSTAND THERE WILL BE NO ARTIFICIAL LIGHTING OFFERED.

Any injury resulting from any of the inherent dangers and risks of skiing or snowboarding, including: changing weather conditions, existing and changing snow conditions, bare spots, rocks, stumps, trees; collisions with natural objects, man-made objects, or other skiers/snowboarders; variation in terrain; and the failure of skiers and snowboards to ski and/or ride within their own abilities.

Participant expressly assumes ALL RISKS associated with the event; Participant agrees and understands these risks include, but are not limited to, risks associated with: equipment malfunction, surface conditions, marked and unmarked obstacles, slick or uneven riding and walking surfaces, surfaces covered with ice and snow; strenuous activity; high altitude; sharing ski area facilities and Event venues with people directly involved and/or not directly involved in the Event. Participant is responsible for reading, understanding and complying with all signage, including instructions on use of the lifts. Participant recognizes that he/she must have the physical dexterity and knowledge sufficient to safely load, ride and unload the lifts. Participant assumes the risks of riding the lifts and engaging in activities accessible from the lifts. Participant understands that snowmobiles, snowmaking, snow-grooming, and Event preparation equipment may be encountered any time. Participant recognizes that falls and collisions occur and injuries are a common and ordinary occurrence of the Event. **DESPITE ALL THESE RISKS, PARTICIPANT VOLUNTARILY CHOOSES TO TAKE PART IN THE EVENT.**

In consideration of engaging in the Event and of permission to use the ski area facilities, Participant agrees to ASSUME ALL RISKS associated with the Event and agrees to hold harmless, release, defend and indemnify Black Hills Chairlift C. d.b.a. Terry Peak Ski Area, and other Event sponsors, its subsidiaries, including but not limited to the subsidiaries that operate Black Hills Chairlift Co/ d.b.a Terry Peak Ski Area, Promoter, their respective agents, employees, representatives, assignees, directors, officers and shareholders (each hereinafter a “Released Party”) from all liabilities and/or claims for injury or death to persons or damage to property arising from engagement in the Event, including those injuries and damages caused by the Released Parties’ alleged or actual: 1) negligence or 2) breach of any express or implied warranty. By execution of this release, the undersigned agrees to indemnify each Released Party for any injuries to Participant or to other person(s) or property that Participant may cause as a result of engaging in the Event.

Participant is in good health and there are no special problems associated with his/her care. Participant: 1) authorizes a licensed physician, dentist and/or other medical provider to carry out any emergency medical care for Participant if incapacitated; 2) accepts responsibility and agrees to indemnify the Released Parties for all such medical expenses; 3) irrevocably grants Terry Peak Ski Area the right of publicity to own and use any image(s) collected of Participant while participating in the Event; and 4) agrees to defend and indemnify the Released Parties for any and all claims whatsoever brought by a third party arising in connection with Participant’s participation in the Event.

In consideration of permission to participate in the Event and of using the ski area facilities, PARTICIPANT CONTRACTUALLY AGREES THAT ALL CLAIMS for injury and/or death shall be GOVERNED BY SOUTH DAKOTA LAW & EXCLUSIVE JURISDICTION shall be in the District Court residing where the alleged incident occurred or in Federal Court for the State of South Dakota. This Release shall be binding upon Participant’s assignees, distributors, heirs, next of kin, executors and personal representatives.
